# CLIFF'S NOTES FOR THE **LEGISLATIVE SESSION**

# On the final day of the Legislative session, lawmakers approved finishing touches that gained broad, bipartisan support on both the tax reform package of bills and the compromise language on a bill to fund transportation infrastructure needs.

While tax reform and infrastructure funding were front-and-center in the public's eye this session, we can't overlook some of these long-sought solutions to problems plaguing our business community. These are major milestones on the path toward economic opportunity in Louisiana.

Bills of note include:

# TAX REFORM

Streamlined Sales Tax Collection. HB 199 by Speaker Clay Schexnayder (R-Gonzales): If approved at the polls this fall, this Constitutional Amendment will create a more streamlined state and local sales tax system in Louisiana by establishing a new statewide political subdivision that will be responsible for streamlining filings, remittance and audits of sales and use taxes.

*Why it Matters:* This bill–overhauling the cumbersome, archaic system currently in place–will finally put Louisiana's brick-and-mortar retailers on equal footing with remote sellers such as Wayfair.

Tax Simplification Package. SB 157, SB 159, SB 160 and SB 161 by Sen. Bret Allain (R-Franklin), HB 278 by Rep. Stuart Bishop (R-Lafayette) and HB 292 by Rep. Neil Riser (R-Columbia) will collectively lower income tax rates, remove the Federal Income Tax (FIT) deduction mandate, reduce the number of tax brackets and simplify state income tax administration.

Why it Matters: Louisiana has one of the most complex and cumbersome tax systems in the country. By simplifying administration and lowering taxes, this tax reform package will make Louisiana more competitive on a national level while improving revenue locally, generating economic growth and vitality.

#### TRANSPORTATION INFRASTRUCTURE FUNDING

**HB 514 by Speaker Pro Tempore Tanner Magee (R-Houma),** as amended, phases in a rededication of proceeds from the state's current vehicle sales tax to the Construction Subfund of the Transportation Trust Fund.

**Why it Matters:** This bill will eventually shift up to \$300 million (60 percent) to projects such as replacing the 1-10 Calcasieu River bridge in Lake Charles, building a new Mississippi River bridge in Baton Rouge, creating a new I-49 and I-10 interchange in Lafayette and more.

## ENDING ENHANCED UNEMPLOYMENT

**HB 183 by Rep. Chad Brown (D-Plaquemine)**, would end the federal enhanced unemployment benefits by no later than July 31, 2021. This move would put Louisiana in line with the rest of the states in the South and help get our employees back to work faster.

Why it Matters: Businesses of all sizes have struggled due to a lack of employees returning to work, given that they were receiving greater benefits to stay home. The results of this bill will help fill thousands of vacant jobs throughout the state.

#### SCHOOL CHOICE APPEALS PROCESS

**HB 211 by Rep. Mark Wright (R-Covington)** would allow the families of children in failing "D" or "F" schools to appeal to the Board of Elementary and Secondary Education (BESE) after being denied enrollment at an "A," "B," or "C" school of their choice and asking for reconsideration from their local district.

*Why it Matters:* This will give families an added option to appeal school enrollment decisions, giving them greater access to educational opportunities for their children.

### BAN ON DECEPTIVE ATTORNEY ADVERTISING

**SB 43 by Sen. Barrow Peacock (R-Bossier City)** outlaws deceptive advertising practices used by some plaintiff lawyers in Louisiana.

*Why it Matters:* This bill will improve our state's legal climate by ensuring attorneys cannot use advertising that masquerades as independent professional, medical or government advice.

### ENVIRONMENTAL SELF AUDIT

**HB 72 by Rep. Jean-Paul Coussan (Lafayette)** requires the secretary of the Department of Environmental Quality (DEQ) to establish a voluntary self-audit program.

*Why it Matters:* A version of this bill has been in process since the 1990s. This rendition–liked by both DEQ and industry–incentivizes companies to do monthly, internal inspections of their facilities to identify and manage potential issues before they become violations.

#### SCHOOL FUNDING TRANSPARENCY

**HB 38 by Rep. Rick Edmonds (R-Baton Rouge)** will require public K-12 school systems and public charter schools to join other state-funded agencies and institutions in "Louisiana Checkbook," the state's fiscal transparency program.

*Why it Matters:* School systems have received significant federal funding from Congress in the past year, and this bill will bring more financial accountability over taxpayer dollars sent to Louisiana's school districts.

## PAYCHECK PROTECTION

**HB 256 by Rep. Phillip Tarver (R-Lake Charles)** allows for teachers to form their own groups or associations and to receive payroll deductions for those activities, requiring annual authorization for the deduction of these dues.

Why it Matters: The bill will give teachers more choice in joining organizations and gives them an even greater voice in how they choose to associate and advocate.

# **PARISH PRESIDENTS SPEAK** AT SCIA MAY LUNCHEON

#### Lafourche Parish President Archie Chaisson and Terrebonne Parish President Gordon Dove headlined the panel for the South Central Industrial Association general membership luncheon in May, as SCIA Past President Chett Chiasson served as moderator.

The three discussed bringing jobs to the area, the changing energy landscape, oil and gas policies coming from the White House and more.

For Chaisson, who took office in January of last year, the main priorities for his first term include tax reform and economic development, and he believes the two go hand in hand.

"We'll be rolling out a tax reform package to the voters in the next few weeks so that we can take to them in the spring of 2022 a reformed local tax structure, which will help not only businesses by lowering your tax burden on your property but your sales tax that you have to pass onto to your consumer," he said to the crowd of local business leaders at the SCIA luncheon.

He went on to add that the tax reform will also help the 39,000 homeowners in Lafourche Parish by taking down their property taxes.

The parish president also highlighted other reasons business should come to the area, such as Port Fourchon, the expanding healthcare network, a significant amount of recreation programs, Lafourche's top-ranked school district and the two local colleges: Nicholls State University and Fletcher Technical Community College.

"Not only can your employees come here and live here, but we can educate them," he said. "We can keep them going with continuing education, and we can let your family grow up here in a positive environment. "

Now in his second term, Dove touted the strides made in the Morganzato-the-Gulf levee system and pump stations for increased hurricane protection, Terrebonne Parish's low millage and utility rates and the Bayou Country Sports Park, the state-of-the-art complex that features multiple ball fields, a splash pad and beach area, among other attractions.

"If we are going to get industry down here, we need quality of life," he said. "Having so much done between hurricane protection and drainage, we can move on to quality of life."

Both officials also expressed pro-oilfield sentiments regarding the coastal lawsuits, arguing that it could persuade companies not to operate in Louisiana. According to Dove, various oil companies own 65 percent of the parish's topography.

"They are a corporate citizen. We treat them like a corporate citizen," he said. **"And we try to protect them as much as we can in the courts."** 

To two also addressed an audience question regarding the ongoing moratorium on lease sales on public lands and waters by the President Joe Biden administration and how it impacts the future of the oil and gas industry.

"What we've told them all along is you're not hurting the majors...Those guys are going to figure out how to diversify. That's what they do," Chaisson said.

He argued that the smaller businesses, like service companies and restaurants, and such community members as surveyors, boat crews and others working as wells are set up will be affected the most by the lease ban.

Chaisson and Dove also expressed that petroleum is needed, despite the push for the world to move towards renewables and electric vehicles.

"You can't run stuff on seed oil. They've got to have oil and gas. You can't run the airline on electric power — you gotta have jet fuel," Dove said.

"I don't think climate change is something that's phony. I think it's something that we have to deal with. But deviating directly away from petroleum products is not the answer," Chaisson said. "...I'm all about trying to diversify as we move forward, knowing that oil and gas and Port Fourchon are still going to be what fuels this nation for years to come."



# BOLLINGER ANNOUNCES GULF ISLAND ACQUISITION AT LUNCHEON

# Ben Bordelon, President and CEO of Bollinger Shipyards was the guest speaker at the April SCIA General Membership Luncheon.

Bordelon began his talk with big news! "We officially took over the shipyard portion of Gulf Island at 3 pm yesterday (April 19th). Over 400 employees are onboarding at the Civic Center as we speak."

Bordelon said, "It's an opportunity for Bollinger to bring some synergies for a facility that could use some focus and attention. They have contracts currently with the Navy to build some anchor handlers and that's right in our scope as well as CRVs for Arkansas State. We plan to make some infrastructure changes and we're excited about it. Puts us touching on 1,800 people with 11 different shipyards operating all around Louisiana. We also share some resources in Mississippi and Florida as well, but all of the Bollinger facilities are right here in Louisiana."

In talking about some of the opportunities in front of them for shipbuilding, Bordelon mentioned some big programs they are bidding on for the government, specifically the OPC contract for the US Coast Guard which, if won, could be built in either Amelia or Houma. Also, because of the Gulf Island acquisition, Bollinger immediately picked up the US Navy as their customer.

Another program from the Navy they are biding on is for CHAMPS (Common Hull Auxiliary Multi-Mission Platform) with potential to build up to 60 of those over 20 years.

In the autonomous world, the LUSV (Large Unmanned Subsurface and Underwater Vehicles) program is out there, and Bollinger is going after that. "The autonomous word is really moving quickly," explained Bordelon. "If you can put a vessel in harms way with less crew or no crew, it makes a lot of sense and technology is allowing that to happen. We're trying to be on the front end of those to be the leading edge."

Bollinger won an industry study on a couple of those which means the government pays you to do a design concept and engineering, then you can short list it in order to bid on it. "It's a lot easier to get a firm price if you have a good design early," Bordelon said.

"Something we are all excited about is celebrating 75 years this year! My grandfather started as a machinist and had one helper. I think he'd be proud of us today. We're excited about where we started and where we're heading," Bordelon said proudly.

Bollinger is building the Sendell Class vessels in Lockport right now. Bollinger won that contract in 2008, delivering the first vessel in 2012. Bollinger is preparing the deliver boat #44 and they are currently contracted out through boat 64 scheduled for delivery in beginning of 2025!

Aside from shipbuilding, the company has also built flood gates. They are currently on their sixth floodgate. They're also building an offshore transfer barge in Amelia. From that contract, they were able to secure a contract to build a \$150 million dry dock, building about 80% of it in Amelia. Because it is so large, about 17,000 tons of steel, they will then float it over to Tampa, Florida to fully erect it.

Bollinger learned a good bit from the effects of COVID. During Covid, Bollinger got up to 22% absenteeism, but never slipped schedule. They've learned to pivot and make changes necessary to keep up productivity. Technology is something they always counted on, but now know they can rely on moving forward. I've never been on so many Zoom calls in my life," exclaimed Bordelon! "I'm thankful for the technology, though. Now I can make more meetings than ever before!"

Post-covid – Zoom calls will continue and have helped Bollinger become more productive. On the blue collar side, Bollinger was creative with testing, and using technology has helped. As strange as it sounds, they have been doing air and water tests using facetime.

In discussing oil and gas, Bordelon said "what a crazy journey! We've made it through a market when some of our close friends did not. We've seen bankruptcies, mergers, and reshuffling of assets." They have had to get creative and pick up new customers. They are even doing things with SpaceX! Bordelon went on to say, "A year ago, when the job came across my desk from Elon Musk, I doubted it. Two years later, we've done over \$10 million in business with him – a great nonoil/gas customer."

In closing, Bordelon said "coming into Houma is a good thing for stability and longevity and we are excited to be here!"

# STATE LAUNCHING SCHOLARSHIPS For adult career training

Adults who want to attend a community or technical college to learn skills needed for construction, logistics, manufacturing or other high-demand fields might soon be able to secure a TOPS equivalent to pay for tuition.

The USA Today Network reports Gov. John Bel Edwards is expected to sign legislation that will provide grants to low- and middle-income workers 21 and older who want to train for a new career via the MJ Foster Promise Program. TOPS is Louisiana's college scholarship program.

Only those making 300% or less over the federal poverty line, or about \$38,000 a year, are eligible. Those who meet the income, age, and career field requirements can be awarded up to \$3,200 a year and \$6,400 total.

"We believe that this is an amount that will give folks the chance to not have to come out of pocket particularly when you consider the other funding that is available through federal Pell Grants and the like," said Louisiana Community and Technical College System President Monty Sullivan. Recipients can also use the grants for industrial certification programs. The grants will cost the state \$10.5 million a year. Sullivan hopes the program will expand in time, noting there are 1.1 million working-age adults in Louisiana who have a high school diploma or less.

The grants are expected to become available in the summer of 2022.

Bollinger Shipyards ("Bollinger"), a privately-held leading designer and builder of steel military and commercial vessels for the past three quarters of a century, today announced that it has acquired Gulf Island Fabrication, Inc.'s ("Gulf Island") (NASDAQ: GIFI) Shipyard facilities, expanding Bollinger's new construction and repair capacity and capabilities to better serve its key defense and commercial customers. Financial terms of the transaction were not disclosed.

This acquisition creates expanded opportunities for Bollinger to better serve and deepen its relationships with key defense and commercial customers with an increased capacity for new projects and footprint, access to a larger workforce skilled in steel construction, improved efficiencies and enhanced economies of scale. Current customers for Bollinger include the U.S. Coast Guard, U.S. Navy, General Dynamics-Electric Boat, and non-defense and commercial customers servicing energy production to dredging. Gulf Island had been building the Towing, Salvage and Rescue Ships (T-ATS) for the U.S. Navy and Regional Class Research Vessels for the National Science Foundation and Oregon State University. These projects conveyed with the transaction.

"The addition of the new Houma shipyard further strengthens our position within the U.S. defense industrial base as a leading shipbuilder and vessel repair company," said Ben Bordelon, CEO and President of Bollinger Shipyards. "For 75 years, we've developed a deep expertise in and proven track record of building reliable, high endurance steel vessels for the Coast Guard, Navy and our commercial customers. As the needs of these customers change and grow, we are constantly looking for ways to invest in and expand our capabilities and innovative solutions so that we can continue to provide them with the highest levels of quality, support and service in our industry."

Bordelon continued, "For three quarters of a century, Bollinger's greatest strength has and continues to be our people and their American ingenuity and quality craftsmanship. I am excited to welcome the Gulf Island Shipyard employees into the Bollinger family. Together, we will ensure that the 'Bollinger Standard' will be the high bar we measure ourselves against for superior quality and safety as we work to deliver the next generation of American made high-performance vessels for our government and commercial customers."

The new Bollinger Houma facility encompasses 437 acres on the west bank of the Houma Navigation Canal, of which 283 acres is unimproved land that is available for expansion. The facility includes 18,000 square feet of administrative and operations facilities, 160,000 square feet of covered fabrication facilities and 20,000 square feet of warehouse facilities. It also has 6,750 linear feet of water frontage, including 2,350 feet of steel bulkheads. Located just 30 miles from the Gulf of Mexico, the strategic location provides short and unrestricted access to the newly acquired Houma facility from open waters.

The acquisition also includes a 15,000-short ton drydock, a 4,000-short ton drydock, a 3,000-short ton drydock and a 1,500-short ton drydock.

Bollinger's acquisition increases the shipyard's growing new construction and repair portfolio. In December of last year, Congress appropriated funds for Bollinger to build four additional Sentinel Class Fast Response Cutters (FRC) for the U.S. Coast Guard. In addition to construction of the FRC, Bollinger is under contract to construct an Ocean Transport Barge and Floating Dry Dock for General Dynamics Electric Boat Division. Bollinger Shipyards LLC has delivered the USCGC GLEN HARRIS to the U.S. Coast Guard in Key West, Florida. This is the 167th vessel Bollinger has delivered to the U.S. Coast Guard over a 35-year period and the 44th Fast Response Cutter ("FRC") delivered under the current program.

The USCGC GLEN HARRIS is the third of six FRCs to be home-ported in Manama, Bahrain, which will replace the aging 110' Island Class Patrol Boats, built by Bollinger Shipyards 30 years ago, supporting the Patrol Forces Southwest Asia (PATFORSWA), the U.S. Coast Guard's largest overseas presence outside the United States.

"Bollinger is proud to continue enhancing and supporting the U.S. Coast Guard's operational presence and ensuring it remains the preferred partner around the world," said Bollinger President & C.E.O. Ben Bordelon. "It is our top priority to ensure that the brave men and women of the Coast Guard stationed in PATFORSWA have the most state-of-theart, advanced vessels as they work to build and maintain the necessary regional alliances to ensure maritime security in the region. Building ships for the Coast Guard provides critical assets to bolster our national security and advance America's interests, both at home and abroad."

Earlier this year at the commissioning ceremony of the USCGC CHARLES MOULTHROPE, U.S. Coast Guard Commandant Admiral Karl Schultz lauded the "enhanced seakeeping" capabilities of the PATFORSWAbound FRCs, saying "these ships are truly going to be game changing in their new theater of operations" and "offer increased opportunities for integrated joint operations with our Navy and Marine Corps colleagues" as the Coast Guard seeks to be part of the whole-of-government solution set in the region.

PATFORSWA is composed of six cutters, shoreside support personnel, and the Maritime Engagement Team. The unit's mission is to train, organize, equip, support and deploy combat-ready Coast Guard Forces in support of U.S. Central Command and national security objectives. PATFORSWA works with Naval Forces Central Command in furthering their goals to conduct persistent maritime operations to forward U.S. interests, deter and counter disruptive countries, defeat violent extremism and strengthen partner nations' maritime capabilities in order to promote a secure maritime environment.

Each FRC is named for an enlisted Coast Guard hero who distinguished themselves in the line of duty. Surfman Glen Harris piloted the first wave of landing craft on Tulagi Island in the Pacific Theater during World War II, and also made a landing against a Japanese force on Guadalcanal Island. Harris was awarded a Silver Star medal by Admiral Chester Nimitz for his heroic combat actions.

#### **BP STRIKES OIL OFFSHORE LOUISIANA** BY MATTHEW V. VEAZEY RIGZONE, AS EDITED BY CHRISTY ALLEY-ZERINGUE

Oil discovery at the Puma West prospect in the deepwater U.S. Gulf of Mexico (GOM).

Drilled by BP on behalf of co-owners Chevron U.S.A. Inc. (NYSE: CVX) and Talos Energy (NYSE: TALO), Puma West – on Green Canyon Block 821 – lies approximately 131 miles (211 kilometers) off the Louisiana coast, BP noted in a written statement. The company added the discovery, located west of the BP-operated Mad Dog field, was drilled to a total depth of 23,530 feet (7,172 meters) in 4,108 feet (1,252 meters) of water.

Operator BP holds a 50-percent working interest in Puma West. Chevron and Talos each hold a 25-percent stake.

"Our resilient and focused hydrocarbons business is core to BP's strategy, and in the Gulf of Mexico we invest and explore in the reservoirs we know best," remarked Starlee Sykes, BP's senior vice president for the GOM and Canada. "We are using our seismic expertise and drilling capability to safely find and develop advantaged oil and gas." BP stated the well encountered oil pay in a high-quality Miocene reservoir with fluid properties similar to nearby productive Miocene reservoirs. The company added that preliminary data support the potential for a commercial volume of hydrocarbons.

"We look forward to evaluating the potential of this discovery and its competitiveness across BP's global portfolio," continued Sykes. "I'm proud of our team for delivering this project – especially during a global pandemic."
